**Subject: Declaration of Final NTA Scores for Joint Entrance Examination (Main) - 2026 for Paper 2A (B. Arch) and Paper 2B (B. Planning) – Reg.**

The Department of Higher Education, Ministry of Education, Government of India has entrusted the responsibility of conducting the Joint Entrance Examination (Main) to the NTA from 2019 onwards.

For Academic Session 2026-27, NTA has conducted the JEE (Main) -2026 for Paper 2A (B. Arch.) and Paper 2B (B. Planning) in two Sessions i.e Session 1 (January 2026) and Session 2 (April 2026):

The JEE (Main) – 2026 Session 2, Paper 2A (B. Arch) and Paper 2B (B. Planning) Examination was conducted on 07 April 2026 in one shift in **13 languages (Assamese, Bengali, English, Gujarati, Hindi, Kannada, Malayalam, Marathi, Odia, Punjabi, Tamil, Telugu and Urdu)** as under:

- B. Arch (Paper 2A) : Mathematics (Part-1) & Aptitude Test (Part - II) in “**Computer Based Test (CBT) Mode and Drawing Test (Part-III) in Pen & Paper**” (Offline) Mode.
- B. Planning (Paper 2B) : Mathematics (Part-I), Aptitude Test (Part-II) and Planning (Part III) in Computer Based Test (CBT).

The JEE (Main) – 2026 Session 2 was conducted at 584 unique examination centres in 319 Cities (including 15 cities outside India in **Manama, Doha City, Muscat, Riyadh, Sharjah, Singapore, Kuwait, Kuala Lumpur, Kathmandu, Abu Dhabi, West Java, Washington, Lagos, Munich and Dammam**).



**NTA Scores are normalized scores across multi-shift papers** and are based on the relative performance of all those who appeared for the examination in one shift. The marks obtained are transformed into a scale ranging from 100 to 0 for each shift of examinees. NTA score is not the same as the percentage of marks obtained. The NTA Score of a Candidate has been calculated as follows:

$$\frac{100 \times \text{Number of candidates appeared in the 'Shift' with raw score EQUAL TO OR LESS than the score of the candidate in the Shift}}{\text{Total number of candidates who appeared in the 'Shift'}}$$

After both Sessions of the JEE (Main)-2026 Examination for Paper 2, the rank of the candidates has been released taking into consideration the best of the two NTA Scores in accordance with the policy already made.

NTA thanks all the Central Government Departments, Embassies of India in countries where examinations were conducted, State and District authorities and various exam functionaries for all the support extended for the successful conduct of the prestigious JEE (Main) 2026 Session 2.
